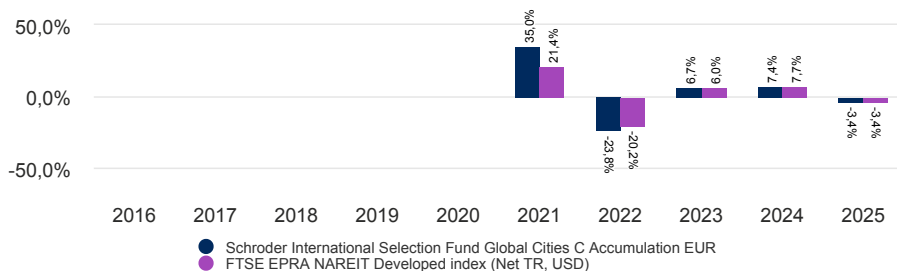

## Risk considerations

**Currency risk / hedged share class:** The hedging of the share class may not be fully effective and residual currency exposure may remain.

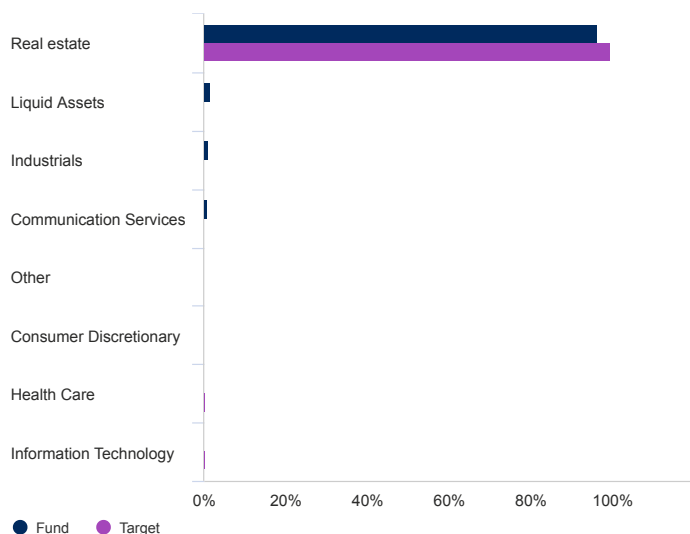

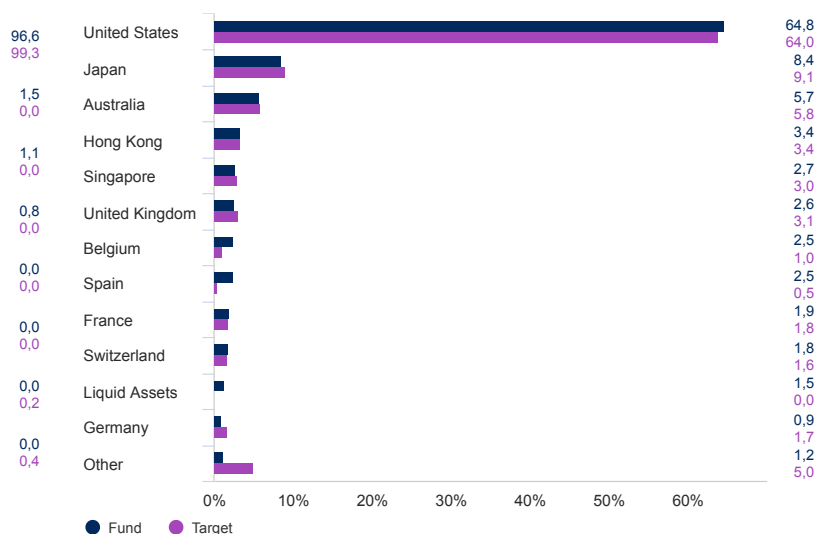

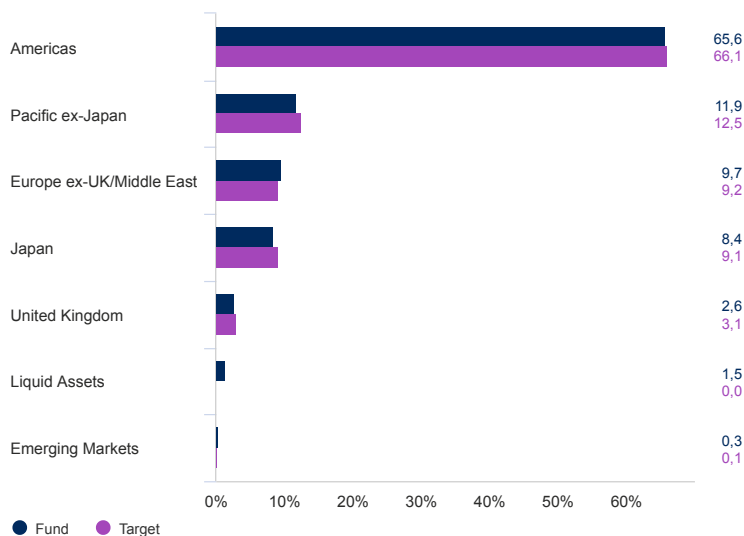

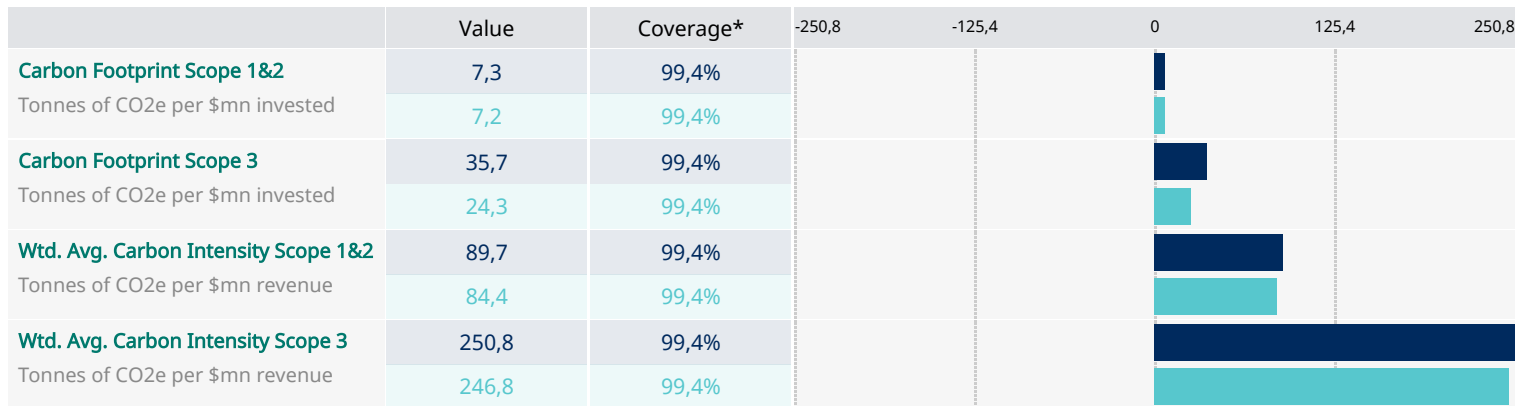

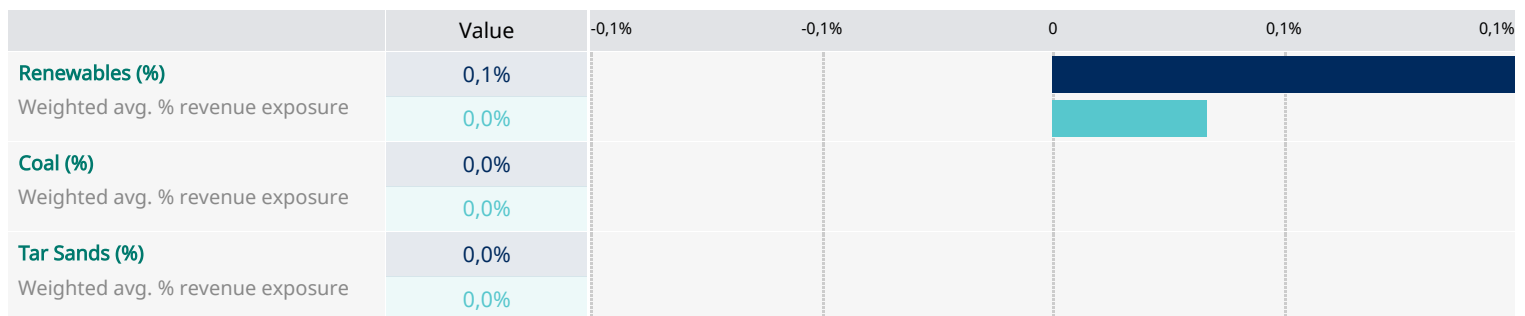
#### Carbon Metrics

This means that Schroders aggregates company-level GHG emissions based on the portfolio's eligible assets only (which are listed equity and credit holdings, where applicable). The energy exposure metrics are calculated based on the revenue generated from these activities by the underlying investee companies and weighted by the fund's holdings. Fund exposure to 'Coal' represents Thermal Coal mining and reflects investments in companies whose coal-related revenues are below the accepted threshold.
